







- Recommended by stoma nurse, R B Hospital.
- I was asking the order had been dispatched.
- I contact Oldham prescribing. I do not contact Fittleworth direct so I don't feel able to comment on this.
- Query regarding an item that is being discontinued.
- Reminder that I had ordered my prescription and late delivery all well eventually no complaints.
- The stoma nurse who was looking after me, she was looking for a particular bag to prevent leakages, Fittleworth provided just the correct bag.

- Always good service. Thank you.
- Generally happy with the service.

- Do not always have the full amount of Auro Cola Maxi Plus in stock, making the delivery late to arrive, but always have enough to cover until we receive them.

- There is always a delay (up to seven days) from the GP and supplier with issues regarding "releasing the items for dispatch". The supplier rings then I have to place the same order online on my local GP's website. If I don't do this there is a delay why do I have to do both?
- Very good.
- Over the past few years I have never been let down by Fittleworth. If I needed extra suppliers they have always been provided. Their service is superb and such a reassurance to someone in my condition (colostomy).
- I have always had good service from the supplier and they are very helpful.
- I used to order direct from Fittleworth by phone but since the Manchester adult community continence prescription service has been set up I tell them by phone and they place order with Fittleworth. I have not had any problems either way.
- Very pleased with the service offered.
- Always received excellent service no complaints at all.
- Doubtful if Fittleworth can improve their service. It is excellent any problems are dealt with immediately and I have normally been informed both by phone and by email. The staff are polite, knowledgeable and friendly and it seems that nothing is too much trouble.
- I find when speaking to the staff at Fittleworth extremely helpful, very polite and try to help with any queries or problems I have, I am very forgetful and at times need to ask if it is possible to get an item to me quickly, they always help, the appliances I require are essential to me, it took a while for my stoma nurse to find the correct urostomy bag. I do not know what I would do without Fittleworth, in one word, excellent. If I have not filled this form in fully I apologise this is due to my memory.
