#### Introduction









- For repeat order.
- I put my prescription in at doctor's. They send for my bags.
- The supplier was initially contacted by the nurse at Basildon Hospital.
- To ask should I be concerned about the delivery of my stoma bags as the news from the government said they
  may be stockpiling medical supplies from the EU if we leave. Fittleworth didn't know.
- Local surgery does not issue paper prescriptions. Phoned supplier to ask if they have received electronic prescription.
- Non-delivery of items.
- The stoma nurse.

### Appendix 2 - Customer comments from question 16 about any of the questions and how the service from this supplier could be improved:

- I was very satisfied with all your services and I am very annoyed that for some reason I've had to change to
  another supplier. Why? I just don't know. This for some mix up at my surgery. I would willingly revert to you being
  my supplier. Thanks for all kindness.
- Q7 and Q13 not applicable. I have been advised of delay in supplies but never that they could not be provided. I
  have never called their care-line out of hours. My prescription is sent electronically to the supplier by arrangement
  with myself and my doctor's practice and works well.
- I can obtain repeat orders from my GP by "IT", but I have to collect the prescription and post it. I would like to order from GP and ensure the order goes to supplier. When will this happen?
- I switched to another company as in the latter stages with you, I was left waiting for essential goods that were
  ordered well in advance.
- My experience with Fittleworth has always been excellent.
- Everyone I talk to is very helpful and nice. Thank you.
- I've never had a problem with Fittleworth. I've also talked over problems with the stoma nurse.
- Excellent service and very helpful staff on the end of the phone. Would definitely recommend this company.
- The service that I have received has been excellent in every way!
- Recently when supplies ran low, a partial delivery was provided, but I think some of the pouches were old stock as the backing was difficult to peel off. I receive supplies bi-monthly but the local GP surgery have to receive a request from me each time for a prescription. It would be easier for me if there could be an arrangement for repeat prescriptions to be automated for life.
- I can no longer order straight to Fittleworth. Wish I could, it was a 4 day delivery, now it's a week, I rated it a very good supplier. My only fault was about 2 years ago my flange changed in the cutting. Before: eye shaped cutting, that's how it was and fitted better on body. Now: lays square with round cutting.
- I have not answered questions 6, 7 and 8 as I have never been told they haven't got my item in stock. Regarding question 13 I have never had to call them out of hours, I am very satisfied with my supplier.
- Excellent to date.
- I would like to say I am pleased with my supplies. Delivered promptly, very polite on phone at all times. I am in my 80s and have had Fittleworth for many years.
- Regarding question 8: prescription ordered via NHS ordering service. Regarding question 6: had phone call from supplier, do not need written note.
- I am offered complementary items, I am not overly impressed with the quality of their disposable bags, otherwise their service is good.
- They suddenly stopped accepting prescriptions from my doctor sent electronically. It took many phone calls to get it put right.
- As long as I get my supplier's stoma bag and items required to me.
- Very good and consistent service for products. No need to visit their premises. I have been with them for years.
- Contact GP to obtain prescription on time, if delayed.
