







- I get a regular order they always go through the order with me, give me date for delivery, which has always arrived
  on time. The telephone staff are always polite and helpful.
- The service I get is brilliant. Thank you.
- Tried others but not as good as Fittleworth.
- I have asked for the nurse to call if she is in the area but have not seen anyone but the delivery service has always been very good. Thank you.
- Some of the questions quite hard to understand and don't seem applicable to me. I have found Fittleworth very
  good and obviously couldn't manage without them. If I had any problems I would contact nurses at the hospital
  where I have check-ups.
- I filled this form out for my wife we get a good service from Fittleworth. Thank you very much. We are in our 80s.
- Very helpful.
- I have used this supplier (Fittleworth) for many years. The service I have received has been excellent. How can I
  persuade my GP to use the online ordering method which would save a lot of paper, postage and time?
- It is normal that I receive four week's supply of catheters. Is it possible to receive a text reminder to reorder? (I'm an old fogey.)
- The problem that we always have is with obtaining a prescription for what amount we need and that being received by the supplier by the specified date, so that the order can be delivered.
- Service is faultless, as are staff at Fittleworth. Never ever had problem with either! Which makes a change nowadays. Excellent, thank you.
- Perfect service!
- Has been shortage of wipes and bags but now rectified.
- I would say Fittleworth have provided excellent compassion and care since my stoma. Well done to all.
- I do not deal directly with the supplier as I have to use a prescription service, most of the questions are not relevant as I phone the prescription service.
- The method of ordering new supplies involves contacting Fittleworth who then contact my GP who then sends a
  prescription to them which they then dispatch to me the bags. This takes two weeks. It's ridiculously bureaucratic. I
  don't see why I can't get my GP to send them a prescription direct upon my request to the GP.
- I've used Fittleworth for a few years and never had a problem with them, if there is a problem they always ring, if it's a problem with my prescription and I have run out of things they always make sure I have an emergency stock.
- Sometimes delay in delivery within a reasonable time.
- Your telephone staff have always been polite and helpful. Only had one quite arrogant person who came across as quite arrogant. Thankfully I've only had to encounter them once.
