







- I am absolutely satisfied with this service and the lovely people I speak to on the phone every month. Thank you.
- My requirements are sent direct via electronic prescription. The only contact I have is to place an order and confirm a delivery date.
- The service is excellent, private and efficient which I would not want altered. I am left feeling very confident that always they are there and can help. Having a stoma and need for appliances you want to know there is a supportive organisation assisting you. When working full-time (excessive hours and travel) contributing via NI consistently, I would not be able to be going to a chemist (locally) with opening hours not compatible, also with local people serving who know me but do not know my condition.
- Fittleworth has been very good with no problems at all. Having a good service helps to make your situation better with no worries. Many thanks.
- Service suppliers excellent.
- Following an error by my doctors surgery, Fittleworth pulled out all the stops to ensure I received goods before I recently went on holiday. I am very grateful for this.
- Very, very satisfied with all services and delivery. I have been with Fittleworth several years and had no problems.
- I don't feel some of the questions apply to my mother. Fittleworth call once a month and then deliver on date stated. They are an excellent service.
- Always diligent and helpful service.
- I was told when I last ordered that my pouches had been "discontinued" and the person I spoke to know nothing about a suitable replacement. Could we not be told in advance if a product is no longer going to be available.
- The service I have received has been exemplary, staff always very polite, friendly and helpful. Thank you.
- I do not know if there have been any advances in my product area (stoma pouches drainable). I would not know how to find out. This may become relevant to me as I enter my senior years.
- From time to time there are waiting periods before contact via phone.
- Excellent service. The quality of my life is dependent on Fittleworth doing their job. It's really good to know, with confidence, that I can rely on them.
- I have always found them very helpful, products delivered very quickly, with bags, wipes, etc.
- Always had very good service Fittleworth over the last few years. Thank you.
- Always had excellent service by Fittleworth. They often ring me to see what I need and sort delivery. Very satisfied.
- Would be interested in any other products or equipment for stoma care. Example cream for sore skin, shower covers for stoma bags, clothing.
- The only way I think this service might need to be improved might be to offer a review. This has only be brought to mind by this survey otherwise I wasn't aware. My mum has stoma bags and I know the hole is cut accordingly to measurements given two years ago. I'm not sure if this needs to be reviewed. Otherwise the service provided by Fittleworth is exemplary and the staff are always polite and informative. Top notch service!
- Making amendments to quantities is pointless as they do not update their records so each request has to state "please remove item X" or "please reduce item Y", I've given up asking.
