







- I missed your call to say when you would deliver and agreed to a delivery date.
- I wanted advice regarding treatment for a severe sore at the site of my urostomy.
- The hospital arranged it.
- I always get called by Fittleworth to put an order in.
- To enquire as to delivery. However my GP practice had not sent prescription request!
- Prescription sent each month via GP surgery.
- One chemist unreliable in getting my catheters.
- NHS script sent via hospital.

Appendix 2 - Customer comments from question 16 about any of the questions and how the service from this supplier could be improved:

- I have been using Fittleworth for several years and I have never had any problems. Thank you for your good service.
- I still want my monthly supply which is stoma pads, black bags and wipes.
- Excellent service at all times, many thanks.
- Good service used Fittleworth many years.
- All I receive are stoma supplies and I am very happy with the service provided.
- Most of the questions are not applicable to a regular customer. Fittleworth are a first class supplier who are always helpful and will do anything to help. I would not wish to change to anyone else.
- Changes to how my supplier sends my repeat stoma order. In the past they rang me, agreed what I needed and a
 date for its delivery. They then obtained the prescription from my GP. Now they ring to check I need supplies but I
 have to send a repeat request to my GP after which my supplier will need to contact me again to arrange a delivery
 date. More time and phone calls to achieve the same end (will always need stoma equipment each month as this
 is for life).
- Have not answered questions that do not apply to me. I am very happy with the service I receive thank you.
- Very happy with service, get my calls monthly to order receive items a few days later! I have been happy customer for several years now!
- I have been using this supplier for many years and have always had excellent service.
- Always happy with the service. I do prefer delivery by your vans as I have mentioned before, Parcelforce tend to
 leave my parcels outside my door or on step not in my greenhouse as required if not available. I noticed the strip
 on parcel which says greenhouse, very small, needs to be more noticeable, as sometimes it is stripped off parcel.
- Satisfied with service.
- Have used this delivery service now for several years. The only time there is a problem it has been due to my GP
 practice not dealing with repeat prescription as agreed.
- On the odd occasion I have had to ring Fittleworth as the wrong size hole had been cut in the pouch. Thank you.
- Fittleworth were previously able to send out prescription items and then obtain the GP prescription after. This
 practice changed and if delays occur now it is usually a problem with the surgery. They ask for phone or email
 requests but do not pass them on as quickly as I would like. This causes the delay with essential products and
 anxiety in relation to my personal needs.
- Overall service has been excellent. On occasion when my surgery has been late submitting my prescription,
 Fittleworth have telephoned me to guery if it is still required.
- Fittleworth is a wonderful firm as is the staff.
- I send an order form which the company send with the goods that I require. To date no problem ever. I have been a customer over many years.
- The staff we have dealt with are always polite, effective and helpful. An excellent service.



Customer comments

- Only once I was short of my drainable pouches and as I was going on holiday I did get very anxious. This was not explained either so I had to ring up to find out what was happening it was dealt with very well.
- I've been using Fittleworth for the last few years and am very satisfied with the service I get from them. When I'm going on holiday it's no problem to order my stoma supplies early and to be delivered when I'm back home. Staff are pleasant and helpful.
- Have used Fittleworth for many years.
- I have been with Fittleworth for many years. I have always found their service excellent. They always contact me once a month so that I can place my order.
- Package just thrown over the fence by delivery driver without even knocking on the door, not impressed. Poor delivery service.
- Very efficient and very friendly staff.
- Texts regarding delivery. Reminders from you regarding repeat prescriptions (they used to happen), rather than placing the onus on the client.
