







Appendix 1 - Specified other reasons for contacting supplier from question 1:

- Fittleworth contacted me in writing saying there was a problem with my prescription you confirmed that the letter had been sent in error as you had over-prescribed to me earlier in the year.
- I contacted Fittleworth to get my flanges pre-cut as I am not able to cut them.
- Leakage around stoma.
- I have not been in touch at all.
- The supplier rings me.
- Because my husband is suffering from dementia and NHS prescription is dispensed to Fittleworth.
- I needed a supply of leg bags to tide me over a coming holiday, the next routine delivery would have been too late.
- To find out whether they have not received the prescription from the Nottingham City Care Prescription Service.
- Introduced to supplier at the hospital.
- Fittleworth contact doctor for prescription.
- Sometimes run out of bags or another product.
- We missed their phone call to reorder (message on answerphone from Fittleworth).
- The prescription was submitted on my behalf by Nottinghamshire Appliance Management Service. I do not have direct contact with Fittleworth.

Appendix 2 - Customer comments from question 16 about any of the questions and how the service from this supplier could be improved:

- If the rest of the NHS could equal the attitude, quality and performance of Fittleworth, matters would be better all round.
- I have had my prescription provided by the company for many years and I am highly satisfied, and very much appreciate them. Thank you.
- The service Fittleworth provides is excellent, I have used their service for many years.
- On several occasions my doctor's surgery have been exceptionally slow to process my prescription. Fittleworth have continued to chase it up and keep me informed. They will also send out an emergency box of supplies when waiting. They are an exceptional company and over many years of dealing with them they have been compassionate whilst delivering a first class service.
- This service is "second to none" over many years.
- I have very good service from you all since I started with you. Thank you all.
- I have always had very good service, no complaints at all. Very happy with you.
- When my ileostomy bags come through from Fittleworth I could do with extra packets of wipes. Otherwise I am

- Would like to say I am always spoken to politely and courteously and any staff member I speak to is always helpful and friendly and speaks to me with respect. Delivery driver is very polite and also treats me and speaks to me in a very respectful manner. It helps.

- Delivery by time is lengthy. It takes 10 days for an order to be raised and delivered.
- The service I received was excellent, but the problem was that they had not received the prescription, because it had not been sent, I had to request the city care again to get a prescription sent to them.
