







- I was using Coloplast, who then changed to Fittleworth.
- My husband is deaf and will not use the telephone.
- Check to see if prescription had been received from surgery.
- The supplier contacted me.
- They contact me.
- To place an order.
- Once when there was a short supply of insert for flanges.
- Initial contact made and details made by Wexham Park Hospital Stoma Care Team. Subsequent contacts initiated by Fittleworth team.
- 90% of the time Fittleworth contact me by telephone every month, although I don't require items so frequently.

Appendix 2 - Customer comments from question 16 about any of the questions and how the service from this supplier could be improved:

- Excellent service, no complaints.
- The telephone is answered clearly, even without my hearing aids I can understand the spoken words.
- Have received excellent service over many years. Staff always polite, helpful and courteous.
- I have always found Fittleworth polite, caring and easy to get hold of any time. They always listen to your enquiries and sort any issues out. I find this a great help as I'm very disabled myself, makes life easier.
- Very good service. Friendly and helpful on phone. Always deliver on date arranged.
- Many of the question do not apply to me. I have a regular repeat prescription sent from my surgery and delivery is normally very prompt. The staff pleasant and helpful if I need to ring them.
- It is an excellent service. I would be lost without them. They are very helpful and willing to help me in any way.
- To improve on this service would be very hard to do.
- The service cannot be improved. Never once, in many years, have I had cause to complain. Please keep things as they are. Where do they find such friendly staff?
- The lead time is too long, delivery is 11-13 days after ordering. Often there would be a further delay, usually within a day of expected delivery, because Fittleworth had not got payment confirmation from my surgery. I would have to go to my surgery to get them to fax confirmation.
- I didn't have to arrange for my supplies to be delivered to me when I come of hospital, it was all done by the RBH Reading. I am so grateful to both them and Fittleworth. A few of the questions did not apply to me. To be honest I cannot think how they can be improved, I have used Fittleworth for the last several years and have found them on time with all deliveries, if they have quoted a date it comes on that date. As for the staff, they are all so very friendly, helpful and always cheerful, even the delivery driver. A great firm.
- Excellent service all round.
- Have been using Fittleworth for many years. Have always been very helpful with advice, prescriptions and prompt delivery. If I had a problem it was immediately of no trouble to them and problem sorted. Great customer service team.
- None. Very satisfactory.
- Excellent service.
- It is disappointing they have stopped sending the pre-paid envelopes. Perhaps they could provide some stickybacked labels.
- I have received excellent service for many years from Fittleworth. Except for one incident.
- Very professional, excellent service.
- Fittleworth always deliver my urostomy bags promptly. When there has been a holdup they phone me. If I need items urgently they always do their best to get supplies for me quickly. This is a good company and service and staff on phone are always very helpful.



Customer comments

- My experiences have been positive both from listening to the interaction between Fittleworth and the stoma care nurses (on my behalf) and my contacts with the Fittleworth team.
- I ring surgery, doctor sends script, I get my supplies from you. No problems (many years).
- Cannot fault this service. The staff always helpful, understanding of situation should I need delivery before date due. Extremely friendly.
- Always helpful, always friendly very good service.
- When my delivery service did not deliver my prescription before I was due to go away next morning on holiday for 2 weeks, the supplier went above and beyond - ensuring I could collect some from their nearest depot.
- The providers regular telephone call (monthly) is based upon users daily usage of the appliances. However my
 usage is less, therefore it is difficult for the provider to receive a request every time. When I need appliances, I
 telephone my request.
- I find Fittleworth to be very helpful if the occasion arises. Always very helpful, sending samples if needed on other problems.
- I have no comments regarding improvement of service in the several years I have used Fittleworth I have never been unhappy with the service. If I have had any queries they have always dealt with them to my complete satisfaction.
- No wipes. No skin lotions.
